#### Discussion for Query #4: Harmony in the Meeting

The pandemic has resulted in a craving to connect. As we worship together using Zoom, we often share more, especially during "joys and concerns". It has deepened our relationships and brought us closer together. We have joyously welcomed attenders from far away who can join us by Zoom.

We do not think that gender affects the way we relate to each other. We are privileged to have strong women leaders in our Meeting.

When communicating with honesty and kindness, it is a way to show our integrity. Some in Meeting are very direct in their words to others. It was suggested that perhaps, if we cannot accept this way of speaking, maybe it is **our** problem.

We have had people attend our Meeting with more conservative views. We have tried to make them feel welcome, and we have engaged in some good conversations. It is important to come into a discussion with the idea that your views might be changed after listening with an open mind. A person could be "the fertilizer for the plant we are growing into." Look for God in ourselves and seek it in others with whom we disagree. We hope we can be respectful when we disagree. Is keeping quiet for the sake of unity being respectful? Is it kind?

In our meeting we are appreciative of the differences in

spiritual journeys and diverse opinions. However, when trying to find unity in worship with attention to business or sometimes in committees, this can be a challenge.

When discussing forgiveness, there was a request for a second hour on this topic. This was expressed as a concern for several of us. Forgiveness implies that someone did something wrong. Are we too quick to forgive?

#### ADVICE:

Friends consider the meeting to be a family in which the welfare of each individual is of utmost concern. For some, the meeting may be the only family in the community. In mutual caring we seek greater wisdom than our own. We listen to the silence within ourselves and to one another with openness of heart. Sharing our pain as well as our joy can bring us closer together, making it easier to ask for help when we need it. Each of us is both giver and receiver, ready to help and to accept help.

Friends try to be aware of those who require special attention with the meeting community. We believe friendly interaction benefits both adults and children. It is the responsibility of adults to recognize and give voice to the needs of children in the meeting. Inactive and absent members require the care of the meeting; *Query continued on Page 4*

All are welcome and encouraged to participate. It will be from 1 to 2 PM, using the same Zoom link as for our 10 AM worship.

The deeper purpose of the ad-hoc committee is to help us, as a community, move towards a sense of the meeting on what actions, if any, we can and want to take to build "Right Relationship" with Indigenous / Native Peoples, including the Meskwaki Nation in Tama. I encourage everyone to reach out to the ad-hoc committee with ideas and suggestions or to join us.

#### Meeting for Worship with Attention to Business 10/11/2020

#### **New Business**

After a time of waiting worship, the clerk called our attention to the business of the Meeting. She explained that because we have guests from Des Moines Mutual Aid present to share with us about the work of their organization and specifically share a request they have of us, we would take up their business first before turning to reports and other business of the Meeting. Friends were easy with the suggestion.

## Meeting with Representatives of Des Moines Mutual Aid

(DMMA) – The clerk introduced Arianna ???? and Ronnie James of Des Moines Mutual Aid and invited them to share about DMMA and their specific request for the Meeting.

Arianna shared about DMMA's request for use of the Meeting's kitchen to prep for meals that are given out to homeless camps and those that don't have the means to eat regularly. Arianna, who is a staff person for Des Moines Mutual Aid's office in Friends House, has volunteered to be there every week to work with the volunteers.

Ronnie shared about the organization's history and answered questions. DSM Mutual Aid was begun a couple of years ago by him, his wife and two friends at Ronnie's request. Ronnie was looking for a way he

could contribute to the solution rather than only worry about what could be done. The group and its work are growing quickly. They often work with other groups wanting to do similar work. By finding other small groups with similar goals they can accomplish much more than any single group could accomplish alone. Anyone in need can get help. At this time the group is prioritizing those most vulnerable and affected by COVID-19: the sick, disabled, guarantined without pay, those limited in work, undocumented, queer, and People of Color. All of their work is financed by donations and carried out by volunteers. When a request for aid is made, they will go into their network of community members who have offered services ranging from delivering groceries/medicine, providing transportation assistance, donating money, etc. and they match the person who made the request with the person/people who can provide support. Their work has included: providing bail money for people arrested during the Black Lives Matter demonstrations in Des Moines, providing funding, picking up and or delivering medicine, food, and necessities to people who are sheltering in place and have lost jobs, have special medical needs, etc. and the project for which they sought use of the Meetinghouse kitchen - providing a hot meal for homeless and those who can't count on a regular meal.

After careful consideration, F/ friends found unity of Spirit in approving the proposal of DSM Mutual contingent on a mutual trial period through the end of November. It will be a time when both organizations can determine if the proposal is a good fit for them. Meeting agreed to waive the customary rental fee for use of their space. Friends hope that the arrangements work well. If so, Meeting's arrangements with the DSM Mutual Aid proposal will likely continue. It could become another example of how small organizations can work together and thereby accomplish much more than any one organization might do by itself.

Peter Clay and Deborah Fisch were appointed Meeting liaisons for DSM Mutual Aid and some F/friends indicated they would be interested in volunteering time or making donations to DMMA. Anyone interested in more information or in learning about other programs they may feel a nudge to join are invited to contact Ronnie at DSM Mutual Aid in Friends House.

#### Library Committee Report

(Virginia Smith) – There was no written report as the Meeting's library has not been used since the onset of the pandemic and closing of the meetinghouse.

#### Peace & Social Concerns Committee Report (P&SC)

(Patty Wengert, convener) – The Committee met on 10/10. They will be presenting a Second Hour on right relationship with Indigenous Peoples. Peter Clay will serve as convener and the purpose will be for the Meeting community to continue to wrestle with these concerns and challenges.

#### Finance Committee-

The Finance Committee met September 23. We continue to learn more about the way the Meeting's finances are structured as we work towards a budget proposal for fiscal year 2020-2021. The committee hopes to have that ready to present to the Meeting in November.

**Building & Grounds** – Dick Douglas reported on damage to the floor tiles in the area right before the door into the original house. A toilet in the room above broke and went unnoticed for long enough that water came through the light fixture in the ceiling. A plumber has since repaired the toilet. Dick will investigate the cost of repairing the damage.

### Holiday Celebrations During the Pandemic-

Since the end of the pandemic is nowhere in sight Friends took time to consider ways in which F/friends can still celebrate Thanksgiving and Christmas with each other, holding on to the importance of the fellowship and Love that is so deeply held and nurtured, perhaps especially during these times. All agreed they want to find a way to celebrate these upcoming holiday seasons.

Thanksgiving - Since the pandemic prevents us from gathering for our annual turkey dinner with the trimmings the clerk suggested that we get extra Zoom rooms so people could gather in small groups for sharing. Friends would obviously need to provide their own food. Charlie Brown volunteered to provide turkey for anyone who otherwise wouldn't be having turkey (for example, because only one or two people would have a hard time eating a whole turkev). Friends said this sounded like a wonderful idea. The clerk said she will take this to Ministry & Counsel for further consideration.

<u>Christmas</u> – It was suggested that Friends gather for the Christmas carol singing. The clerk said other groups have done this by having everyone mute their mics except whoever is playing the instrumental accompaniment.

Others suggested we might have some special worship and go around the group with each person sharing about something for which they are thankful.

#### Second Hour on Apportionment October 24, 2020

Thank you to Carol Spaulding-Kruse, Ann Robinson, and the finance committee for organizing and facilitating a second hour on DMVF apportionment to Iowa Yearly Meeting – Conservative (IYMC) and thank you to Rebecca Bergus, treasurer of IYMC and member of the West Branch meeting, for meeting with us. The purpose of the second hour was help us be better informed about what the apportionment is, its history, what it is used for, etc., to help us thoughtfully evaluate this portion of our budget in the future.

We began with silence. Rebecca then answered questions about apportionment. She reminded us that answers can also be found in the yearly minute book of IYMC.

### What does the apportionment pay for?

- 1. About <sup>3</sup>⁄<sub>4</sub> of the apportionment goes to Scattergood School/ Farm: \$54,000 to the general fund plus \$2000 earmarked for facilities upgrades
- 2. Initially intended to cover the cost of two boarding students attending Scattergood falls far short of that now
- Although Scattergood is the primary "project" of IYMC – "our beliefs in action" as a safe

and inclusive place for nontraditional students, IYMC contributes a small percentage of Scattergood's budget

- When Scattergood has funding issues, it goes to supporters for additional help rather than to IYMC
- About 11% of the total goes to donations to Quaker organizations
- 6. Delegate expenses to attend FCNL, Earthcare, etc.
- Trustees get \$1000 maintenance of Hickory Grove Meeting House
- 8. IYMC expenses which include:
  - Printing and distributing the minute book
  - The clerk's expenses
  - Some of the expenses for Mid-Year Meeting, including support for speakers and children's programming. (Expenses for IYMC gathering and MidYear Meeting are primarily supported through freewill donations.)

### How many monthly meetings pay apportionment to IYMC?

- 1. Only 11 official monthly meetings contribute
- 2. DMVF is the largest and contributes about 20% of the apportionment; West Branch contributes about 16%
- Meetings are not told what to contribute; they decide for themselves
- Meeting representatives to IYMC need to know ahead of time how much the meeting intends to donate to the apportionment

#### Why are the budgets for the IYMC and IYMC gathering budgets considered separately?

Rebecca did not know the answer to this.

Doesn't a lot of the money get used the same way? (Aren't some of the organizations that IYMC supports the same as ones DMVF supports)?

• Yes and they are Quaker organizations and the financial support is nominal and meant as support and recognition of the organizations' work, as well as to provide partial support for staff of the organizations who often send representatives to IYMC gatherings to present and bring information.

#### How has the apportionment changed over the years, as the number of monthly meetings and members of monthly meetings has declined (if you know). Is this a practice that goes back to the beginning of lowa Yearly Meeting (Conservative)?

- IYMC budget generally stable from year to year
- Budget and apportionment done simultaneously
- DMVF has decreased our contribution for the past two years; the first year Decorah made up the difference

Comments/Questions to Consider

- Is Scattergood School and Farm the best use of DMVF's funds (through our apportionment)?
- What can DMVF afford to contribute? Does our apportionment appropriately match the size of our budget?
- Just because we've always done apportionment this way doesn't mean we have to keep doing it this way.
- To feel more a part of IYMC, attending and participating in the mid-year and yearly gatherings is key.
- How can we continue to think and talk about our priorities as individuals and as a meeting and what it means to be a Quaker?

There was interest in scheduling another second hour to continue the conversation.
