Letter to the Editor from Des Moines Valley Friends Opposing Reinstatement of the Death Penalty

February 28, 2021

To: Speaker Pat Grassley and Majority Leader Whitver and All Members of the Iowa House and the Iowa Senate Judiciary Committees

Des Moines Valley Friends Meeting of the Religious Society of Friends (Quakers) stands in strong opposition to Senate Study Bill 1004 and to House File 62, two bills seeking to reinstate the death penalty in Iowa.

The Religious Society of Friends has long opposed the death penalty. We believe that

Meeting opened with the clerk reading a quote from Valarie Kaur’s book, See No Stranger, before inviting F/friends into waiting worship in preparation for tending to the business of the meeting.

Nominating Committee Report
(Dorothy Lifka, convener)

Pam Blackburn has resigned as treasurer and Friends House board representative. Kelsea Gillespie has volunteered to serve as interim treasurer, pending Meeting approval. Fred Nelson has agreed to be FH Board representative, pending Meeting approval.

Dick Douglass has agreed to be the Finance Committee representative to the Property Management Committee.

The Nominating Committee appreciates Pam's many years of service and hard work as the treasurer. Thank you also to Kelsea, Fred and Dick.

Minute 02.21.01 – We heard the Nominating Committee report (printed above). We approve the nominations of Kelsea Gillespie as interim treasurer and Fred Nelson as the second representative of Meeting to the Friends House Board, with much appreciation for their and Dick’s willingness to serve Meeting in these ways.

We particularly expressed appreciation for Pam Blackburn’s many years of faithful service as the Meeting’s assistant treasurer and treasurer.

DMVF Finance Committee Meeting Report (Catherine Dietz-Kilen, Convener)

The committee met 1-27-21.

Attending: Catherine Dietz-Kilen; Dick Douglass, Kelsea Gillespie, Ann Robinson, Cindy Winchell; M&C Liaison: Deborah Fisch; Nominating Committee Representatives: Claire Cumbie-Drake, Dorothy Lifka, Carol Spaulding-Kruse

Ann confirmed her decision, shared prior to the meeting, to step down as Finance Committee convener. She has agreed to continue serving on the committee through a transition period, and said she is very pleased that Catherine has agreed to serve as convener to lead the committee through a fresh start.

The Nominating Committee affirmed the news that Pam Blackburn has decided to resign as DMVF treasurer and also plans to resign from Friends House Board. Catherine took leadership for the rest of the meeting. She asked members to take turns sharing their thoughts/priorities at this time. In summary: Members shared

appreciation for work of the treasurer, assistant treasurer and Finance Committee and its convener. There have been, and still are some concerns, but we believe they are being addressed. F/friends agreed that getting the financial review done and presented is an important accomplishment. F/friends appreciate Pam’s long service and hope we can do something to honor that.

Nominating Committee members, who were in attendance, said they hoped to firm up recommendations for interim treasurer, assistant treasurer and Property Management liaison. Cindy was asked if she would be willing to stay on as assistant treasurer. She agreed. It was also announced that Kelsea has agreed to take on role of interim treasurer -- with help from Pam and Cindy and the Finance Committee.

Kelsea said she is willing to take on this role, but it will be challenging, as she can’t be in Des Moines on a regular basis. She said everyone will need to practice patience and good communication. Kelsea also said she is glad Cindy is willing to stay on (as assistant treasurer) and she believes they will work together well.

Cindy expressed support for recommendations in the financial review. She said she is willing to stay on as assistant treasurer and cares for the Meeting, even though she wanted to be honest about her hurt feelings. She said she wants to look ahead and that she believes their plans are very do-able with positive communication. Cindy also said she is willing to keep picking up

deposits and making a monthly report of donations. She just sent out yearly donations letters with Pam's help.

Dick agreed to serve on Property Management through this fiscal year as liaison from the Finance Committee.

Among the next steps the Committee discussed meeting more frequently for now to keep moving forward. The next meeting is scheduled for 02/19/2021.

DMVF Finance Committee Meeting Report for 02/10/21

Attending: Catherine Dietz-Kilen; Dick Douglass, Kelsea Gillespie, Ann Robinson, Cindy Winchell; M&C Liaison: Deborah Fisch.

The meeting began by reviewing the notes from the 01/27/2021 committee meeting

with special attention to the proposed minute. Catherine reported on a pleasant and educational conversation with Pam Blackburn regarding the means to begin the process of transitioning the treasurer's responsibilities from Pam to Kelsea Gillespie, during which, Pam expressed her commitment to assisting Kelsea in any matter that she could.

Kelsea reported that she had a several conversations with Pam, and that they are looking forward to working together on the transition. Kelsea has been given access to our QuickBooks account and finds QuickBooks to be intuitive. Cindy has added Kelsea as a person with full access to the accounts at E-bank. Kelsea has had an opportunity to review the bank statement in depth.

Katie Jacoby has set up an email specifically for the treasurer through our website, which we will be using for all treasurer's questions and communications. Using this dedicated email will help provide a history of communications for any future treasurers.

Kelsea and Pam discussed a plan whereby Pam will reconcile our financial accounts and reports through February 1st, at which date, Kelsea will take over that responsibility. (Note that after the committee meeting, this matter was further discussed and the decision was made that Kelsea will take over the books "as is" and, with Pam's assistance and advice, will complete the reconciliation of previous financial reports.)

Cindy reported that she has moved the two automatic debits

that previously came from the EdCo Financial Plus account over to our E-bank account, and she will set up bill pay for Clean Des Moines at our E-bank account. Kelsea and Cindy, working with Andrea and in consultation with Pam, have paid the outstanding bill to Clean Des Moines for November, December and January cleaning and have also paid for February. Cindy has added Catherine (and removed Ann) from the ability to view the E-bank accounts.

The Committee will look into seeing whether the DMVF Friends Journal subscription has been paid.

Deborah Fisch drew attention to the Committee that the annual charge for the Meeting website was charged to the home account of Deborah and Katie Jacoby. The current budget included funds for the Meeting to take over the responsibility for paying the annual fee for the website.

The Committee authorized the reimbursement to Deborah and Katie for the most recent annual fee that was charged to their personal credit card.

Catherine has started a list of items that the Committee will need to discuss at future meetings and tasks that need to be completed. Committee members are invited to submit suggestions for the list to assist in setting priorities for future Committee meetings. It is the intention of the Committee, at its next meeting, to review our current budget to see if any amendments are necessary and to prepare for a future meeting to consider the budget for fiscal year 2021/2022.

Proposed minute:

The cost of cleaning the meetinghouse was greater than was anticipated at the time that the 2020/2021 budget was prepared and approved. The DMVF Finance Committee recommends that the 2020/2021 budget be amended to increase the budget line for Hospitality/Cleaning Service by \$600, to \$1,350, to cover the unanticipated cost of cleaning through the end of the fiscal year. Additionally, the DMVF Finance Committee recommends that the 2021/2021 fiscal year budget be amended to increase Income-Regular Receipts by \$600 to \$24,920.00 to maintain balanced budget for the fiscal year.

We listened carefully to the Finance Committee reports for their meetings on 01/27/21 and 02/10/21 and appreciate all the work they are doing our behalf. The Meeting approves the following minutes proposed by the Nominating and Finance Committees

Minute 02.21.02 – The DMVF Nominating and Finance Committees are pleased that Kelsea Gillespie, who has a background in finance, has agreed to serve as interim treasurer, with the blessing of the Meeting. Ministry & Counsel Committee Report (oral report from Dorothy Lifka) The Ministry and Counsel Committee met on 02/07/21.

Attending: Gordon Bivens, DJ Newlin, Andrea Holveck, David Drake, Deborah Fisch, Dorothy Lifka

Committee members started with a time of worship and then considered members/attenders who might have special needs for which Meeting could be of assistance.

Dorothy shared that Nominating Committee had met with Finance Committee at their 01/27/21 business meeting and that Nominating would bring forward names of Friends to recently vacated Finance Committee positions.

The DMVF representatives to the Friends House transition committee joined the M & C committee meeting to discuss proposed by-laws for Friends House. The group met again on Feb. 11 to complete the discussion.

As liaison from M&C to Finance Committee, Deborah also reported on the 01/27 joint Finance and Nominating Committee meeting.

Report on Edna Griffin Mutual Aid (Peter Clay and Deborah Fisch) – Our meeting's support of the work of Edna Griffin Mutual Aid's (EGMA) on behalf of the Des Moines houseless/homeless population living in camps in our metro area continues to go well. EGMA continues to come in early on Wednesdays to prepare meals in our kitchen, which they then distribute to the camps. On alternative Sundays, they also distribute clothing to the camps. They are storing limited supplies for preparing food and some of the clothing in a limited area of the Meetinghouse basement. The communication with Arianna Calleja (our contact person) remains good and positive. We believe that EGMA is showing care and being responsible in their use of our meetinghouse and especially of our kitchen and basement areas. This includes keeping these areas properly clean and well maintained.

During this time of extreme cold, Arianna shared this concern, "All of us have been extra concerned for our houseless neighbors. We've been bringing out extra propane and heating resources, but there's only so much these things can do when living outdoors in these conditions."

We (Peter and Deborah) believe that Meeting should continue this partnership as it is a good way for our community to provide support to the neediest among us.

Requested supplies and how to donate:

Arianna shared that the following are needed: tents, tarps, batteries, empty or full large propane tanks, socks, new underwear, flashlights, pants and boots. As for how to donate, we both have Venmo and PayPal accounts. We can also accept cash donations.

Minute 02.21.04 – We heard the report from Peter Clay and Deborah Fisch, Meeting liaisons to the Edna Griffin Mutual Aid, . We unite with their appreciation for the work being done by EGMA and are grateful for the small role we can play in that ministry by providing space for them to prepare meals and collect clothing, sleeping bags and other things that could help homeless/houseless people still living outside in the bitter cold weather.

The clerk asked that the minutes reflect appreciation to Peter and Deborah for the time they are spending staying in touch and offering support for EGMA. Deborah reported that Peter has been doing the bulk of the work and she has supported Peter as possible.

Peace & Social Concerns Committee Report (Patty Wengert, Convener) – Peace & Social Concerns Committee

offered the following rough draft of a letter reflecting the Meeting's opposition to the reinstatement of the death penalty in the state of Iowa. They ask for approval of the basic letter with permission to edit the letter before they send it on behalf of Meeting under the DMVFM clerk's signature to the State Judiciary Committee:

Des Moines Valley Friends Quaker Meeting is writing to share with you our long-standing historical opposition to any legislation seeking to reinstate capital punishment in the State of Iowa, namely Senate File 29, currently before the Senate Judiciary Committee.

Our Faith and Practice Discipline states our historical position concerning the dehumanizing concern we hold as a large part of our Christian living in this community. "Friends have been historically opposed to capital punishment because it violates the sacredness of life. The application of the death penalty is brutalizing and degrading to those who impose it. It leaves no room for the reformation of character, nor for the revision of the sentence in the event of a miscarriage of justice. Our religious principles

upholding the dignity and worth of a human being do not allow for punishment without the opportunity for reform of the offender. We continue to actively oppose the use of capital punishment."

Scientists agree, by an overwhelming majority that the death penalty has no deterrent effect. Statistics by the FBI, the ACLU, and Amnesty International all demonstrate, non-capital punishment states actually have lower murder death rates than capital punishment states consistently to this date. Statistics also demonstrate a continuing disparity by both class and race for imposition of capital punishment. Black and non-Hispanic death row inmates nationally were 42 percent in 2018. Around 34 percent of all death row inmates executed since 1977, have been black and non-Hispanic. (@usafacts.org)

Former Senator and Governor Harold Hughes in 1974 had this to say of capital punishment, "'Thou Shalt Not Kill' is the shortest of the Ten Commandments, uncomplicated by qualifications or exception.... It is as clear and awesomely commanding as the powerful thrust of chain lightning out of a dark summer sky."

Please vote no on advancing .04this dehumanizing legislation.

Minute 02.21.05 – We listened carefully to a letter prepared by P&SCC in opposition to proposed legislation that would reinstate the death penalty in the state of Iowa. The Iowa Legislature is currently considering the reinstatement of the death penalty. P&SCC proposes this letter be sent to the

Senate Judiciary Committee over the name of the Meeting's clerk. We approve the letter with the understanding that any edits will not change the spirit of the letter.

Friends shared a concern that shorter letters are more likely to be read by elected officials and Meeting members were in unity with this, recommending those editing the letter look for ways it can be shortened in length. Meeting also asks that P&SC draft a shorter letter that individuals can then use to adapt as personal letters or postcards to be sent to the Judicial Committee and State senators. Because timing is important, there is no need for P&SC Committee to resubmit their new draft to Meeting for approval prior to mailing. Friends appreciate P & SC members undertaking the writing of this minute of concern on behalf of the Meeting.

Re-opening Ad Hoc Committee Report (Dorothy Lifka, Convenor) – Present: Dorothy Lifka, David Drake, Andrea Holveck, Deborah Fisch

The Re-opening Committee met via Zoom on 01/22/ 2021. The Committee was in unity to discuss opening the meetinghouse to in-person meeting for worship at some time after the February meeting for worship with attention to business using a hybrid model (a combination meeting of in-person and via Zoom). We also support keeping a Zoom (or other on-line service) option long-term.

The following items will need to be addressed further: technology, safety, and cleaning.

Technology – It was suggested that we start with a basic technology that those meeting outside the meetinghouse this summer used: a laptop that would be shared by those attending in-person. Katie Jacoby is willing to research other equipment we might purchase for longer-term use, such as a monitor. We currently have a laptop computer at the meetinghouse.

Cleaning – We would resume weekly cleaning once we are meeting in-person, and we will want to come up with guidelines for cleaning chairs, doorknobs, etc. after each meeting for worship or other in-person use of the meetinghouse.

Safety – We would require the use of masks and recommended social distancing. Chairs would be set up in socially distanced “household” groupings. We recommend setting up a “one way” entrance and exit from the meeting room.

We also recommend keeping the windows of the meeting room open to allow good ventilation of the air during any time the meeting room is in use, looking into purchasing an air purifier, and keeping a sign-in sheet (to be discarded after every several weeks) in case it is necessary to notify Meeting attenders about possible virus exposure if someone worshipping at the meetinghouse would be stricken with COVID- 19.

Social “Hour”/Soup Meals – Food would not be provided after meeting for worship, nor would such things as the monthly soup meal be offered until it is possible for “normal” activities

to resume. Whether or not a person has been fully vaccinated against COVID-19, masks should continue to be worn until the national medical team declares it safe for the country to resume “normal” activities.

Minute 02.21.06 – We listened carefully to the report of the Re-opening Committee Report. We recognize we have varying comfort/safety levels when it comes to returning to offering meeting for worship at the Meetinghouse. There were not only questions about what kind of electronic equipment would be needed to hold a joint Zoom/in person meeting for worship, but also whether we really want to offer hybrid meetings once it is possible to meet in-person. Recognizing that we have not been able to achieve a unity of Spirit concerning re-establishing in-person meetings for worship during this session, the clerk suggested we table consideration at this time. Ann will check with monthly meetings within IYMC who are using varying types of hybrid meetings for worship at this time and report her findings to the next meeting for worship for business when we revisit this concern. Katie and Bob also offered to look into some ways we could use technology appropriately in the meeting house to allow hybrid meetings.

Library Committee Report – (Virginia Smith, Convener) reported that all 2021 Motto Calendars have now been distributed.

Other Business

Upcoming IYM(C) Midyear Meeting – Cindy Winchell reported she recently received a

request from Jackie Leckband (a member of Bear Creek Friends Meeting and of the IYM(C) Midyear and Yearly Meeting program planning committees for yearly meeting youth) that the IYM(C) Midyear Meeting Planning Committee has asked DMVFs to plan a Zoom offering for younger Friends attending the scheduled Zoom Midyear Meeting.

Cindy will communicate with Ann Robinson, Kelsea Gillespie, Billie Wade, Dorothy Lifka, Deborah Fisch, and Peter Clay to consider some possible offerings. Jackie Leckband of Bear Creek Meeting has also offered to help with planning.

Ann reminded Friends that last year we asked the IYMC Midyear Meeting Planning Committee to release DMVF from having to continue every year to plan and run programming for youth attending Midyear Meeting. Apparently, this message had not reached this year's planning committee. Meeting approves gently reminding the planning committee of our request, and though we are happy to provide some electronic programming this year, we still hope to just be expected to take turns with other meetings in future years.

There being no further business the clerk closed meeting for worship with attention to business with a brief moment of worship.

capital punishment does terrible harm to everyone in our society. This includes the individuals required to carry out the killing and the families of both victims and perpetrators. We believe that every human life is sacred.

“No person is beyond redemption. The God-given dignity and worth of every human being requires that punishment allow for reform of the offender and possible revision of the sentence. Execution is brutalizing and degrading to the individuals who impose it and to the society that endorses it.” From Faith and Practice-The Book of Discipline of Iowa Yearly Meeting of Friends (Conservative) Religious Society of Friends.

In addition, the death penalty is disproportionately applied to People of Color and especially to African-American men. The systemic racism reflected in this discrepancy is intolerable and unacceptable to a humane and civilized society.

Execution by the state in the name of retributive justice only perpetuates the violence in our society. It has no deterrent effect upon interpersonal violence. Across the United States the trend is to recognize that the death penalty has no place in our country. New Hampshire recently abolished the death

penalty and Virginia will do so shortly, becoming the twenty-third state to abolish the death penalty in all circumstances.

The Bible is clear- “Thou Shalt Not Kill.” We urge you to reject these bills and focus instead on transforming the conditions that lead to violence in our state of Iowa.

Query Discussion
CIVIC RESPONSIBILITY
March 3rd, 2021

Attending: Peter Clay, Andrea Holveck, Jack Holveck, Patty Wengert, Billie Wade, Ann Robinson

We considered how Friends have found themselves in conflict between our religious convictions and the laws of the State. Quakers historically have had strong religious scruples against serving in the military that are grounded in our Peace Testimony. Friends helped enslaved people travel on the Underground Railroad, which was also a conflict with the laws of the State. One Friend mentioned that proposed legislation to allow people to use vouchers for private school is a conflict between our convictions to support public education and the proposed law for our State.

Friends in our meeting are very concerned about much of the legislation now before the Iowa legislature, including suppressing voting rights, a transgender bathroom ban, reinstating the death penalty, banning use of the 1619 Project for school curricula, dramatically increasing penalties for civil disobedience and more! We discussed how hard it is to believe the meanness and cruelty that human beings can show to one another and how that is reflected in many of these proposed laws.

Many of us, despite sometimes feeling powerless still choose to speak and to act for what we believe is right. We are learning to separate how we choose to speak and act, from whatever the impact or outcome is. This way we can maintain our integrity

while also caring for ourselves.

The poet David Whyte helps us by suggesting different questions we can ask ourselves or others may lead to new conversations and differences in outlook. An example would be “What has made you so angry?” When people feel listened to, they may be less more open to communication.

It can be so difficult to share different perspectives with family, or with friends, who seem to be looking at life from such divergent places. Where is the common ground to be found? Can we choose to keep the door open at least a bit, despite the chasms we experience? We observed that establishing relationships over time might succeed in building bridges of mutual respect and understanding. We asked ourselves if when this appears to be impossible can we still be open to trying?

Some Friends are finding prayerful walking is helpful. Another shared that reciting the Lord’s Prayer was centering. We agreed that having a regular spiritual practice was meaningful as we grapple with the current struggles and challenges in our country and around the world.
