### State of the Meeting DMVF Report to IYMC

Des Moines Valley Friends has continued to meet for worship primarily on Zoom, with a small group meeting outside the meeting house last summer and fall. Recently a small group of Friends has been meeting inperson both inside and outside of the meeting house; we continue to use Zoom to keep us all connected.

The pandemic highlighted both strengths and concerns of the meeting. Members of the Ministry and Counsel Committee focused on care of our members and attenders and checked on Friends who were not attending the Zoom meetings on a regular basis. Attempts were made to adjust meeting traditions to foster community while keeping everyone safe: at Thanksgiving several Friends made extra helpings of food which were delivered to solitary members: we had our traditional Christmas caroling on Zoom complete with piano accompaniment and harp solos.

Our concept of membership expanded as we welcomed members, attenders and visitors from other parts of Iowa, other states, Spain, and Germany. We are currently exploring how best to continue our combination of in-person and virtual worship to continue to include Friends not currently living in the Des Moines area.

Members commented about a perhaps paradoxical increased intimacy while meeting virtually. There were more messages during meeting for worship and during the sharing of joys and concerns which followed meeting, people shared at greater length about what was going on in their lives.

We missed the presence of Friends who are not comfortable with attending meeting for worship virtually. We missed the presence of children in the meeting house and were grateful for the one family whose children were with them for worship on zoom.

Fewer people have attended business meetings, which have also occurred on Zoom. Nonetheless, we have addressed weighty issues both in business meeting and during second hours including AFSC moving out of our attached neighbor, Friends (continued on page 7)

#### **DMVF** Meeting for Worship with Attention to Business June 13, 2021

As meeting for worship with attention to business opened, the clerk shared the following from "To Be Broken and Tender: A Quaker Theology for Today" by Margery Post Abbott:

These days, when I want to describe someone I would like as a mentor, or a healthy, vibrant Quaker meeting, I tend to use the words, "broken and tender." A broken, tender community contains many individuals who have found that place in themselves where they can be still: a place where love has broken apart the bounds of the ego. Such people are transparent: compassion is visible in their movements and intent. They are formed by the meeting even as they shape it. With even a few such people present community is more tender in its care for one another and more passionate in the concern for the well-being of the world. A broken, tender person or meeting is far from flawless. People still bump up against each other roughly and do foolish things. People still hurt each other even when intention is not there. But there is space for seeing the heart of the matter and coming to know what was meant. There is space for mending what

# was broken and coming to forgiveness.

**Review of 05/2021 Minutes** 06.21.01 – The May 2021

**<u>00.21.01</u>** – The May 2021 minutes were approved as printed in the June *Friendly Line*. However, if anyone, upon further perusal, sees a typo or error please contact the recording clerk by the end of this week. All reported typos or errors will be corrected in the copy of the minutes placed in the permanent minute book. Any significant error that would change the meaning of a report or minute will be corrected and published in the next month's *Friendly Line*.

<u>**Treasurer's Report</u>** (Kelsea Gillespie) – If you know of any unpaid expenses or have any receipts to turn in for the fiscal year ending 06/30/2021, please contact me as soon as possible. Our IYMC allocation has been paid in full. As of 04/30/2021, we were 83% of the way through our fiscal year, with 109% of anticipated income received and 77% of anticipated expenses accrued.</u>

06.21.02 – The Treasurer's report was approved with appreciation. Friends were reminded that 06/30/2021 is the end of the current fiscal year, so any outstanding receipts need to be sent to the treasurer as soon as possible. If someone does not yet have a receipt for a reimbursable expenditure, they are asked to email or text the treasurer with the amount and the reason for the expenditure so the Finance Committee and she can have a clear idea of final expenditures for the fiscal year as they consider next year's final budget proposal.

#### Finance Committee Report The

following are notes from the committee's meeting on 05/26/2021. (Katherine Dietz-Kilen)

#### **Old Business**

- EdCo/Financial Plus Account will be closed soon.
- Additional research confirms that financial records should be kept for seven years.
- More work on Committee/treasurer/assistant treasurer description was tabled.
- After business meeting approval last month, six small, designated funds were closed out and put in the General Reserves or Property Management Fund . The closed funds do not include the Jean Sandstrom Memorial Fund or the Education and Enrichment Fund.

#### New Business

Kelsea Gillespie reviewed the April financials for the committee. She was pleased to report that DMVF has already exceeded its income goal for the year by the \$2,400. The Meeting has also been careful with our expenses, so our net income (income minus expenses) as of the end of April was \$8,677. The committee appreciates the staunch, generous support from members and also from those who use the meetinghouse.

We will ask approval to increase the telephone budget line in 2020/2021 budget to \$700 but continue to think this is a cost we may be able to reduce or possibly eliminate in the future.

Meeting will receive a special donation for technology, for which we are grateful. We will seek approval to add a line item

for technology in the current budget for \$5,000, so that the money can be spent during the current fiscal year. We are informed that two Meeting members have incurred costs that can be reimbursed from this fund. Funds not used during FY 2020/2021 will be placed in a Designated Technology Fund for FY 2021/2022. Funds not spent during FY 2021/2022 will be transferred to the Meeting's General Reserves and the designated fund will be closed at that time.

The committee considered developing a policy regarding payment of bills, to state that when appropriate and prudent, we can use funds in reserve to pay bills in a timely manner (see below). Current policy or practice has been that we don't pay until adequate funds come in as part of that year's income, which means bills incurred at the beginning of the fiscal year may not be promptly paid.

We reviewed the proposed 2021/2022 budget and will present a draft to the June meeting for worship with attention to business. Recommendations include:

- Continue an "austerity" budget
- Increase phone line item to \$700.
- Keep the apportionment to IYMC at the level it was for FY 2020-2021 (\$14,500).
- Need to add \$20/month for internet service, paid quarterly to Friends House.
- Create flexible fund for Finance Committee to use for unanticipated costs due to Friends House transition

 Keep budget line for Property Management at zero.
<u>DVFM Policy Regarding</u>
<u>Payments of Bills</u>

The DVFM treasurer is responsible to ensure that the bills of the Meeting are timely paid from the funds of the Meeting. It is the policy of the Meeting that the treasurer first pays the bills from funds received in the current fiscal year, but may, at the treasurer's discretion, use funds from the Meeting's general reserves, if necessary, to timely pay amounts due, and if by doing so, the Meeting's financial well-being is not compromised.

#### **Other Business**

In July, at the beginning of the next fiscal year, (FY 2022) we will plan to put another message in Friendly Line about the Meeting's finances. 06.21.03 – We listened carefully and with interest to the reports of the Finance Committee, including the first draft budget for FY 2022 which runs from 07/01/21 to 06/30/2022 and amended policy ecommendation. All policy changes in the reports were approved. However, Friends asked Finance Committee to consider whether each year some additional money could be put in the line allocated for Property Management. This would give Meeting a better opportunity to build up funding to cover all or a major portion of costs for unscheduled major repairs and/ or that could be used to fund yet unknown major renovations.

Friends also asked the Committee to consider if Meeting would be able to add another \$500 to the amount set aside to cover DMV's annual share of Yearly Meeting's operational expenses (including Scattergood Friends School donations) for the next fiscal year. In the last two years, DMV Friends reduced its allotment by \$1000, and last year, Decorah Meeting increased its allotment in response. The committee heard the suggestions and will take them into consideration at their next meeting.

We appreciate all the work being done by Kelsea as treasurer, Catherine Dietz-Kilen, as the new convener, and Ann Robinson, former convener who stayed on this year to help the new Finance Committee get going. We acknowledge with thanks the many hours and careful work done by the whole committee.

We thank the anonymous donor for providing funding that allows Meeting and some individuals needing it to upgrade computer technology so we can offer attendance at worship and most Meeting events via Zoom, so that those joining from outside the meetinghouse and those returning to worship at the meeting house will be able to see and hear each other as the Spirit works in us and through us.

#### Ministry & Counsel Committee

**<u>Report</u>** (Gordon Bivens) – The committee held its regular meeting First Day, 06/06/2021. Present via zoom were Dorothy Lifka, Andrea Holveck, D.J. Newlin, Deborah Fisch and Gordon Bivens.

We heard a report that the special committee to ensure spirituality in hybrid meetings had met. Appreciation was noted for the new computer for use in

the meeting room and other equipment helping to make it feasible to have hybrid meetings. Some concerns about seeing and hearing those at the meeting house were expressed and will be given to the special committee

Concern for members and attenders with known special needs were discussed and ways in which the committee might be of help were noted.

We approved the proposed State of the Meeting Report for FY 2021 and will present it for approval and ask if approved it be sent on to the clerk of IYMC and the clerk of IYMC Ministry & Counsel by the Meeting clerk. (see State of the Meeting Report, as approved, beginning on page 1 of this FL).

06.21.04 – We received the report of Ministry & Counsel and the proposed State of the Meeting Report to IYMC for fiscal year 2021. We listened carefully to the beautifully written report. It reminded us of the many ways Meeting has been held by the Spirit of Love during the continuing COVID pandemic, and the many ways Friends have found to reach out to each other even though we couldn't meet in person. We approve the State of the Meeting Report, and request copies be sent to the Yearly Meeting clerk and clerk of the IYMC Ministry & Counsel by the Meeting's clerk.

## **<u>But Not Read During Meeting</u>** for Business

All reports received prior to meeting for worship with attention to business were distributed by the clerk via email. Meeting approved the suggestion by the clerk that because of the amount of business before Meeting this month reports distributed prior to business meeting, not requiring action by Meeting, be accepted by consent and not read. However, those reports will appear in the minutes in The Friendly Line as a part of the June 2021 Minutes.

#### Peace & Social Concerns Committee Report (Patty

Wengert) 06/01/2021. Present: Jack Holveck, Peter Clay, and Patty Wengert – We have \$383.95 in our committee account. We approved a \$50.00 donation to DMARC.

We reviewed our past year of Zoom meetings and our

committee activity and participation so that we can update yearly meeting in July. Our committee had reviewed the listings of organizations where Meeting has had member(s) serving on boards or in which Meeting has been co-sponsors of events occurring in the city.

The committee also reviewed donations sent by our committee to other organizations. Iowa Peace Network continues to keep Iowans up to date on statewide activities for peace and justice. We continued to support our local food pantry and food banks.

We wrote an opposition letter to death penalty reinstatement legislation introduced in the Iowa legislature this past session. The bill was not passed.

There has been a degree of sadness as the AFSC Immigration program and AFSC office relocated from Friends House this March, laying down the former AFSC program and beginning a joint organization with Iowa Justice for Our Neighbors. The new group is now Iowa Migrant Movement for Justice, with many of the former AFSC employees still involved in the merged group. Our committee has been supportive of the new group. While there is sadness and a heavy heart with the changes, we look forward to being supportive of Iowa Justice for Our Neighbors and AFSC in the future.

Our committee was supportive of local shelters for unhoused persons as well as the Sanctuary Movement in an assisting capacity. Individual members were active with Blacks Lives Matter groups and activities. Our committee discussed Right Relationship with Indigenous People, the idea of land acknowledgement in relation to real property by Caucasian settlements. A member was also involved with Racial Justice Teams through Iowa Citizens for Community Improvement seeking deescalation, police training and advocating for changes to address racial profiling in our community.

P&SC Committee meetings will remain the first Tuesdays of the month at noon for the next couple of months.

#### DMVF Religious Education Report to IYMC FY2021

This past year Des Moines Valley Friends continued to provide religious education to the youth of our meeting through Zoom due to necessary COVID-19 restrictions. Although it was hard for the adults and children not to be with each other in person, there was one very important benefit. This allowed us to include children from two families who no longer live in the Des Moines area.

Three elementary and middle school age Friends attended First Day School regularly. Topics covered included exploring other faith traditions and the Quaker testimonies. The topic that got the children most excited was the story of the children's meeting of 1663. They spent several First Day classes writing and developing a short play based on materials from the Meeting as well as from what they could find on the Internet, and they have been planning and rehearsing for the past few months. They (as well as some invited adults from

Meeting) are planning to present the play virtually for Meeting members this summer. Working on the play has led these young Friends to take more responsibility for their own learning as they have "schooled" their teachers and other adults on how to use Zoom more effectively and shared how they think the project should go.

They have expressed some interest in researching and writing articles for the DMVF's monthly newsletter, *The Friendly Line*.

We have also provided "Young First Day School" virtually during the week for two to three younger children using a mix of books, songs, on-line resources, discussion and projects. We've used the *Sparklers* curriculum and the Quaker "Spices" as our focus.

Adult religious education has consisted of answering the Queries and Second Hour discussions. The latter included discussing the impact of AFSC leaving our shared building space and our vision for the Meeting moving forward, DMVF finances, and issues of immigrant rights.

One book was donated to our library this year: "To Be Broken and Tender: A Quaker Theology for Today" by Margery Post Abbott.

As one of the Des Moines Area Religious Council (DMARC) reps for Des Moines Valley Friends, I'm writing with my report about their annual meeting. The meeting took place 05/20/2021 on Zoom.

Unfortunately, I was 30 minutes late because I got the time wrong. However, the meeting was recorded, and I am sending all of the links as resources, should people wish to explore their annual summary further.

In sum, DMARC not only rose to the occasion during COVID to maintain services when there was already quite high demand, but they also seemed to thrive in areas of their mission that one might expect had been hampered by COVID.

In the portion of the meeting that I did attend, and after watching several of the short videos to catch up on what I missed, here is what I learned:

The organization rapidly assembled COVID protocols for n- contact delivery in response to the onset of the pandemic. Sometimes they had to get creative, like tying a rope to a grocery bag and hefting it up to an open window where it could be retrieved by the family. Mobile pantry service also continued.

They implemented a Farm to Families Food Box program, a project of the USDA. According to Matt Unger, DMARC's CEO, this is the fifth of five rounds in which DMARC has participated. The program ended 05/31/2021.

Advocacy is a big part of DMARC's work. That is, for the folks at DMARC, addressing food insecurity as both a legislative and community equity issue is as important as addressing the issue of hunger in our area. DMARC is a member of the <u>Iowa Hunger</u> <u>Coalition</u> which combines resources with other state organizations that address food insecurity.

School closures meant an interruption of access to regular nutritious food for many schoolage children. DMARC and the Food Bank of Iowa stepped up to <u>provide supplemental food</u> to families in the DMPS district.

Interfaith engagement and supporting dialogue among diverse faith traditions is a vital component of DMARC's work. Despite COVID, the organization again helped to plan and execute an annual Interfaith Youth Camp sponsored by Drake's The Comparison Project. A <u>screening</u> <u>of films</u> made by student storytellers will take place 07/21/2021 from 3-5 PM.

The organization also continued an Interfaith Dialogue group, which gathers weekly for book study on topics related to faith, diversity and tradition.

I was inspired by the unflagging efforts of the folks at DMARC to continue service to our community despite the challenges presented by COVID. With more families than ever struggling with joblessness and homelessness, DMARC's role is vital, and their approach to interfaith-based service demonstrates the work of love flowing throughout our community.

(Deborah Fisch on behalf of Peter Clay and herself) Edna Griffin Mutual Aid (EGMA) continues to use our kitchen for preparation of meals for the houseless on Wednesday morning. Since Meeting is starting to open up the meetinghouse and plans to begin letting previous renters resume meeting there, Deborah plans to talk to the volunteers. Our hope is they will be able to continue to use the kitchen, but they will need to be able to clean their pots and pans, label food in sealed containers in the fridge, and store their pots, pans and other materials in their storage place across the hall and not on the kitchen counters.

#### New Business & Announcements

The Entertainment Committee, which plans all activities of IYMC in session other than the business meeting sessions, reminded F/friends that this year's annual sessions will be held via Zoom meeting, hopefully for the last time. Annual End of the School Year <u>Picnic</u> This year's annual picnic is being postponed to a date to be announced toward the end of summer. It is hoped that by postponing the annual event F/friends will be able to meet in person and have a real potluck. Need for Volunteers for Buseum

Interns coming to the U.S. with Michael Luick-Thrams to assist with the tour of his Buseum have been denied Visas to get into the country. Because of this, additional volunteer are needed. Some F/friends from Meeting have already volunteered to help while it is in Des Moines, but more would be welcome. The Buseum is scheduled to arrive in Des Moines on 07/01 and will be here until the morning of 07/05.

There being no other business Meeting concluded. Meeting for business is scheduled next for 07/11/2021. It will be the beginning of a new fiscal year.

Very few people have attended this year's Advices & Queries which were moved to a midweek evening and held on Zoom. Nonetheless the discussions have been lively and there has been a comfort level in meeting from our own homes.

Like many meetings, DMVF feels challenged by the aging of our membership. Most of our children and grandchildren do not identify as Friends. An Ad Hoc Outreach Committee is planning to meet to consider ways to reach out to the community so that we can be more inclusive. Yearly Meeting could help by sharing how other meetings are addressing this issue and resources to address this issue. Several Friends have invited others to our meeting; each of us could be more mindful of individual opportunities for outreach.

#### Query Discussion: EDUCATION June 2nd, 2021 via Zoom Attending: Andrea and Jack Holveck, Dorothy Lifka and Brock Wommack.

How can we most effectively foster a spirit of inquiry and a loving and understanding attitude towards life?

Friends discussed how quickly children are able to receive information from the internet, and how the pandemic has sequestered them more to the internet. It was also discussed that learning is ever present, and a helpful discipline follows this thread; Don't waste your time on what you don't want to learn.

The Netflix program "Connected" is recommended. Also recommended is the book "The Great Necessity."

What effort are we making to be better acquainted with the Bible...the history and principles of Friends...contributions of other religions and philosophies to our spiritual heritage?

Friends discussed how important the idea of a community is to educate children of the Meeting. It takes a village. The support of other faiths is an example to children within the Meeting. Their rituals are an expression of different religions. The best education for children is observing adults—it is more important than lessons.

In what ways can we encourage an educational process that is consistent with the values Friends cherish?

Scattergood School provides an example of the process. Another Friend recalled that dinner time at the table provided

a steady education of many different values, for discussions continued every night and could last several hours; opening the world to each at the table. Another Friend remarked on an osmosis that occurs watching adults and siblings interact.

#### How do gender based expectations affect the goals we set and the way we learn?

Friends discussed how finally our national culture is moving away consciously from gender expectations. It is also to be noted how more girls are present now in STEM education.

Do we take an active and supportive interest in schools, libraries, and other educational resources in our communities and elsewhere?

This is the strong suit of Quakers, determined gathered Friends in the discussion. One Friend reminded us that in the late 1800s, the one room schoolhouse in Iowa counties began as a Friendly project that was devolved to become Iowa grade school education. Others spoke of their experiences within programmed Meetings as equally Friendly and spiritual. All in the discussion agreed in the strength of recognition that the testimonies of men and women are equally valid and supportive. How do we prepare ourselves and our children to play active roles in a changing world?

Friends agreed that a valuable tool is to be prepared to change. Keep up with current events and view as many different sources of news as possible; locally, nationally and internationally. Praise children for their accomplishments. Friends discussed how current education stresses testing rather than knowledge and understanding, leaving parents in the role of expanding their children's experience. One Friend expressed the importance of writing essays as a part of testing.

The Meeting for query discussion ended with a silent gathering in worship.

#### QUERY #1 for July: Meeting for Worship

#### ADVICE:

Meeting for worship is the heart of the meeting. In the silence, we seek direct communion with God, the Spirit, conscious of the seeking of others. From the depths of living silence, may come an awareness of the presence of the Spirit. Sometimes the silence is unbroken. At other times a message may come to any one of us which seems intended not simply for the worshiper, but for the gathering as a whole. If the message is not expressed, one may feel a sense of not having been faithful to a leading of the Spirit, but if it is spoken, a sense of peace may follow. We are most effective if we speak clearly, simply and from our own experience. Because we are unique individuals who come from varied backgrounds and life experiences, our messages reflect diversity. Part of our worship together is listening with an open spirit, holding the speaker in love, remembering that silence after the message is part of the message. Our daily lives are

linked with meeting for worship. In the search for truth, Friends are encouraged to spend time in individual study, meditation or prayer and to be open to other sources of inspiration around us. The life of the meeting may be strengthened by a deep level of sharing, discussion or worship at times other than regularly scheduled meetings.

Friends should make an effort to arrive at meeting for worship prepared in mind and spirit to support one another in a worshipful atmosphere. As we give and receive, in speech or in silence, we are drawn together in the life of the Spirit. QUERIES:

Are our meetings for worship held in a spirit of expectant waiting and communion with the Holy Spirit? How do we prepare our hearts and minds for worship?

How do we refer to that which is divine? How does ascribing gender to the Holy Spirit affect our worship? How do we integrate our daily lives with meeting for worship? Do we seek opportunities for worship outside of meeting?

How does the vocal ministry of the meeting contribute to its spiritual life? In what ways do we recognize and nurture vocal ministry and other spiritual gifts?
