Congratulations to the Meeting's own Jan Mitchell, who has been named to the <u>Iowa</u> <u>Women's Hall of Fame by the</u> <u>Iowa Commission on the Status</u> <u>of Women</u>. Her fellow honorees are Dr. Roxann Marie Ryan (Cresco), Cornelia Clark, Grinnell) and Donna Reed (Denison).

. Jan was recognized as Iowa Teacher of the Year in 1997, and over time, has been a leader in many organizations, including the American Association of University Women. She is especially known for assisting the education and social mobilization of Iowa's Latina students, championing women's rights, supporting the Hispanic community and founding the nonprofit Al Exito, for which she



was recognized in 2019 with the Iowa Latino Hall of Fame Robert D. Ray Award for Equity and Justice.

Due to COVID, this year's induction ceremony will be held virtually on Saturday, Nov. 6.

### Review of 07/2021 Minutes

Minutes of the 07/2021 meeting recorded by Claire Cumbie-Drake were printed in the August 2021 Friendly Line.

**<u>08.21.01</u>** – The July 2021 minutes were approved as printed in the August *Friendly Line*. If anyone, upon further review, sees an error please contact the recording clerk by the end of this week. All reported errors will be corrected in the copy of the minutes placed in the permanent minute book.

### **Committee Reports**

### **Finance Committee Report**

(Catherine Dietz-Kilen, convener) The committee met July 28, with Catherine Dietz-Kilen, Cindy Winchell and Dick Douglass.

Review Monthly Financials -

Kelsea has not yet received the bank statement from Financial Plus, so she was unable to have the June financials ready for our review. We have closed the Financial Plus bank account, so this difficulty should not arise in the future. Although, Kelsea will be able to have the financial reports done before the business

meeting, we decided to hold on reviewing the June financials at the business meeting because they are the end of the year financials, so it is important for the committee to review them first. We expect that we will have June and July available for business meeting in September. Schedule for FC monthly meetings We had decided to change our monthly meeting night to the fourth Tuesday at 7:00 p.m. We will continue to meet by Zoom. M&C Representation to the Finance Committee In the event that the clerk of M&C would like to have a representative join us for our meetings, that person continues to be welcome. Financial Activities - We discussed the means by which the treasurer can best be kept informed of the financial activities of other committees. The payments that the Treasurer makes on behalf of the Meeting fall into three categories: bills, donations and reimbursements. Bills - Bills are planned and paid regularly. They do not need any action to be taken by any committee before payment is made by the Treasurer. An example of bills; our quarterly payment to Iowa Yearly Meeting. Donations – Donations are

<u>Donations</u> – Donations are generally made by the Peace and Social Concerns Committee. Another example is our donations to affiliate organizations that are in our budget. Cindy and Kelsea will develop a simple form that Peace and Social Concerns members can use when the committee decides to donate. The form, or the information for that form.

should be submitted to the Treasurer so that she will know that the donation has been approved by the Peace and Social Concerns Committee (or any other committee that is donating from its budget line) so that she will know it is authorized. She will know the amount of the donation, and where to send the donation. Payment of the donations made to the affiliate organizations that are in our budget, will be approved by the Finance Committee. Reimbursements

Reimbursements are generally for expenses incurred by members of the meeting on behalf of their committees. An example would be the purchase of supplies for the kitchen by members of the Hospitality Committee. Those committee members who will be making purchases are strongly encouraged to let the Treasurer know that the purchase has been made, or if possible, even in advance of making the purchase. Doing so allows the Treasurer and the Finance Committee to keep aware of the finances of the organization and also allows the Treasurer to make timely reimbursements to members who incurred the expenses, thereby avoiding the need to amend earlier financial reports. **Retention of Financial** Paperwork - Pam Blackburn, former Treasurer, has all the paper records for the Meeting's finances when she was the Treasurer. Pam has graciously volunteered to look through any documents that are more than seven years old and determine if anything needs to be retained. For example, if the installation of

the geothermal heating and cooling system is more than seven years old, then documentation of that cost should be retained. Anything that we do not need to retain that is more than seven years old, Pam will dispose of. For anything that is less than seven years old, Pam will let us know when she has completed her project so the paperwork can be retrieved. <u>Biennial Corporate Report</u>

When Cindy picked up the mail, she noticed we had a letter from the Secretary of State which indicated that our biennial report was past due. Cindy completed the report for us and updated the records, listing Kelsea as our Treasurer and Cindy as the Registered Agent. We thank Cindy for taking care of this task. **08.21.02** – We listened carefully and with interest to the report of the Finance Committee, reviewed by Catherine Dietz-Kilen, convener. Kelsea, the Meeting's treasurer, has not yet received the bank statement from Financial Plus and so she could not give a separate Treasurer's Report.

The committee has changed the day and time of their meetings. They will now be held on the *fourth Tuesday of the month at 7:00 p.m. via Zoom*. Catherine said that anyone interested in the work of the committee is welcome to attend the meeting.

Catherine also asked that Friends make a good effort to turn in bills needing reimbursement at the time of a purchase and not save them up or turn them in to the Treasurer weeks or months later. Every time that happens Kelsea has to go back and edit each report for the months in which each purchase occurred, so financial reports are accurate.

Ministry & Counsel Committee Report (M&C) (Dorothy Lifka reported on the July and August 2021 M&C meetings.) The Committee considered the concerns of Friends.

Gordon Bivens agreed to continue as convener of the committee for this fiscal year.

M&C expressed appreciation for the work of the Finance Committee and clarified that the M&C liaison to the Finance Committee had been attending Finance Committee meetings on behalf of the meeting clerk. The Finance Committee is now meeting and reporting on a monthly basis and the clerk feels there is no longer a need for either the liaison or the clerk to continue to attend the FC Meetings, unless requested by that committee.

A concern was raised about who should be authorized. (besides the clerk) to use the clerk's email list that is currently accessible to anyone receiving an email from the clerk, such as the Friendly Line or a notice of the death of a member or attender. The clerk's email list contains the addresses for members and attenders, as well as members or former attenders no longer living in the Des Moines area, but still interested in the life of DSM Valley Meeting. It is also sent to some Quaker organizations that have asked for a subscription for Friendly Line. In recent months members/attenders of Meeting have used that list, without consulting the clerk or Meeting, to tell Friends about personal interests they believe others in

Meeting would want to know. Concern was also expressed about the possibility that if more and more F/friends start using the clerk's list to send out notices, others might start ignoring or even blocking emails from the clerk's address and end up missing an important announcement. And finally, there was a concern that someone might use the clerk's list to post something not in keeping with Meeting's faith or practice.

After a careful discussion M&C recommends that *in the future any email needing to go out to all DSM Valley F/friends be sent through the clerk*. The clerk will discern if the email should be sent to all F/friends and, if so, send it out via the clerk's email list. If not, the clerk will inform the individual of her discernment and suggest they bring the concern to the appropriate committee for consideration.

F/friends are also asked to consider if it is really necessary to "reply all" every time they respond to an email from the clerk or committee.

**08.21.03** – We were happy to receive an update on the work of Ministry & Counsel. Meeting approves the recommendation that all requests for an email to be sent using the clerk's list of Meeting members and attenders be submitted to the clerk. S/he will discern whether or not the proposed email notice needs to go out to everyone through the email list, be printed in the Friendly Line or be posted on Meeting's website, or possibly isn't appropriate to be shared widely without further seasoning.

#### Liaisons to Edna Griffin Mutual Aid Banart (Daha

Mutual Aid Report (Deborah Fisch and Peter Clay) – Deborah reported that her most recent conversation with Adrienna was just before the business meeting of Seventh Month. She clarified that at that time, Adrienna and she talked about the City having recently given notice to those living in one of the camps near the river that they (the houseless) had a couple of days to move their homes and properties, or they would be removed by the city. It is Deborah's understanding that if people don't move by the deadline, properties (tents, clothing, personal possessions, etc.) are confiscated and destroyed, resulting in some people losing everything they own except the clothing they are wearing and anything they might have had with them that day (backpack and contents, food, etc.) Many residents of the camp community are left with nowhere where they feel safe to sleep or take shelter in inclement weather. They must start all over in finding clothing, food and other things such as lanterns, flashlights, food, cooking pots, coats, gloves, hats, clothing, etc. Homeless shelters have been running full, and besides many will not stay there due to fears such as of COVID-19 exposure, theft or attacks.

Adrienna says that EGMA has been working with Des Moines Mutual Aid to try help feed and find donations of food, clothing and shelters for the houseless, and the City's decision to uproot some of the tent communities has added to those already pushed to the limit needs.

We also talked about an anticipated swell of new homeless individuals and families that would occur after 07/31/2021 if/when the government's ban on evicting those delinquent in paying their rent that was imposed when people started being laid off or losing jobs due the closing of all non-essential businesses and services during the pandemic. Happily, that ban was continued until at least 10/03/2021. That date will be coming up soon enough. Hopefully, since the Delta variant of COVID-19 is on a sharp increase, the ban will be renewed as people continue to be unable to go back to jobs or find jobs that pay enough to cover their costs without having to make choices about rent, food, medication, etc. I suggested at that time that if they found themselves in need of extra help due to the rise of houselessness in the area that they should let Meeting F/friends know because I was fairly sure there were individual F/friends willing to help as they could and the Meeting as a whole would want to discern if there were ways they could be of assistance as well. I will be trying to get in touch with EGMA again to touch base with them.

Would Meeting be willing to continue with this arrangement through fall and/or winter?

<u>8.21.04</u> – Friends expressed appreciation for the work EGMA is doing and are glad Meeting has been able to make the kitchen available to them to help with that work. Meeting asks Deborah to find out if EGMA would like her to bring a request to Meeting to continue to extend the use of their kitchen through fall and into winter, whether or not the meetinghouse continues to be used by Meeting or other groups who have begun to use the facility again.

### Library Committee Report

(Virginia Smith, convener, via Dorothy Lifka) Virginia has agreed to serve as clerk for one more year. Charlie Brown donated *The Boy, the Mole, the Fox, and the Hors*e, by Charlie Mackey. It is highly recommended by several who have read it. At first glance it may seem to be a children's book, when in fact it has something to share with people of all ages

<u>08.21.04</u> – We received the report with thanks to the committee for their work. We are pleased Virginia accepted reappointment as convenor to the committee. Special thanks to Charlie Brown who donated a new book to Meeting's library.

### **Peace & Social Concerns Committee Report** (Patty Wengert, convener)

Andrea Holveck set up the Zoom meeting for Patty Wengert to convene the meeting, 07/06/2021. Attending were Patty Wengert, Peter Clay, Jack Holveck. We see that Billie Wade and Steve Shivers are also now on the committee. Our meetings have been on the first Tuesday of the month at noon. Let us know what works best for everyone!

The Committee approved one emergency donation of \$50.00 to be sent to the Friends Peace Teams African Great Lakes Initiative for an emergency

response to a volcano eruption, followed by an earthquake.

Members discussed how we might be supportive of current events and movements recognizing both Indigenous humans/people rights as well as Black Lives Matter humans/ personal rights movement. P&SC currently has an ad hoc committee to explore issues related to Right Relationship With Indigenous People among us and how we might study and explore also the "land back" rights/ land recognition/ and or what reparations may be made going back to even, the age old, 40 acres and a mule legislation that are being voiced by our fellow community members actively expressing their rights. Reparation legislation has been proposed in Congress for years regarding just forming a commission to discuss reparations. There are several books and essays we Friends could read and discuss going forward.

Recently there has been recognition that former boarding schools operated by religious groups (including some by Quakers) felt (wrongly) that assimilation was the "right" or only path forward. Discovery of mass graves of children at a school in Canada recently shone a light on this practice. It reminds us that doing what we think would be of help to our neighbors may not produce a just result regardless of whether they were good intentions at the era and time. It is documented that forbidding First Language, and requiring assimilation was demanded over preservation of culture language and personal

freedoms; matters contrary to the Constitution.

A member mentioned the hope to partner with another congregation via Zoom to broaden our concept of worship around the world. One member currently has a connection with a group in Rwanda and feels something could be set up there if desired.

Also, there are essays and books on the subject of any reparations for past wrongs of our governments, and our own past privileges. *Between The World and Me*, we and other committees may want to explore.

Our committee will meet via Zoom on 08/03/2021 at noon and we hope to meet for an in-person soup lunch fundraiser for 09/19/2021 after meeting for worship.

Peace and Social Concern Committee Meeting 08/03/ 2021 (Patricia Wengert, convener) Our committee had hoped to meet via Zoom, but two members had health issues come up on that day, so the meeting was cancelled. The next zoom meeting will be held on 09/07/2021 at noon after Labor Day.

**08.21.05** – The clerk read the P&SC Report for July. As noted, there was no committee meeting in August.

#### Religious Education, Building & Grounds, Hospitality Committees\_– No Reports

Proposed Letter to Send to Iowa Governor Kim Reynolds, Des Moines Mayor Frank Cownie and Members of the Des Moines City Council 08/12/2021

Members of Des Moines Valley Friends Meeting of the Religious Society of Friends (Quakers) believe that there is that of God in everyone. We believe that all people have the right to lead lives of dignity and are entitled to safe, affordable housing, clean water, healthy food, jobs that pay a living wage and access to a quality education.

Our Quaker testimonies of Simplicity, Peace, Integrity, Community, Equality and Stewardship help us express our lives according to our understanding of what our faith requires as we seek to witness to the world. The recent ending of the moratorium on evictions that may result in millions of American families, including thousands of dependent children, losing their homes during the now resurgent COVID-19 pandemic concerns us deeply.

We understand that housing is a complicated issue. We also know that Congress has authorized substantial resources to assist landlords and tenants during these very troubled times. Quakers seek to build what we call "Beloved Community" that includes each of us. Jesus said, *"Whatsoever you do to the least* of your brothers and sisters you do unto me." The "least" among us are the most vulnerable people

in our Des Moines and Iowa communities. They are our neighbors. In truth, we are one another and our shared future can be bright if we let love guide us. We urge each of you, as leaders in our city and in our state, to do everything you can to get the available resources to the people who desperately need them.

Finally, we encourage and appreciate the creative new approaches to addressing housing inequities that we know you are already exploring so that safe and affordable housing may become a reality for everyone. ## August Query Discussion -Meeting for Worship

Seven attended the discussion, August 25, led by Billie Wade. **Are our meetings for worship** held in a spirit of expectant waiting and communion with the Holy Spirit? How do we prepare for worship?

One Friend said that she usually feels a sense of community and readiness to worship, "especially as we have ventured back to in-person meeting. "Just by stepping on the sidewalk and walking into the Meeting House."

There was general agreement that it is valuable to prepare for meeting for worship, though we don't always manage it. One friend said he has found turning off the television and radio from the time he wakes on First Day morning to hbe helpful.

A newer member said she finds it beneficial to sit down a bit before worship, take a couple of deep breaths, and ask mystery to "tell me what it wants me to know, what it wants me to do, how it wants me to proceed."

One member often speaks to the divine light at the beginning of worship, saying "God I'm here listening. I'm trying." **How do we refer to that which is divine? Does ascribing gender to the Holy Spirit affect our worship?** 

One Friend who has been reading about the Reformation has sbeen thinking about how we think of and refer to the divine. She grew up Lutheran, where the view of God seemed to be very negative – one had to constantly prove themselves worthy. Now that she has experienced a faith that views God as good and loving, a light within every person, she could not "go back."

One raised in a black Baptist church experienced the God represented there as male, angry, vengeful, punitive and judgmental, and she witnessed a lot of mean-spirited behavior among member outside of church. In the last few years, she started taking a closer look at approaching the divine. She believes we are all connected, "that the divine is a part of us and

we are a part of it." She landed on the name "mystery" because other names for the divine seemed so gender assigned, and she thinks the divine probably doesn't have a name that is available to us as humans.

One said that from early on, she questioned always referring to God in male terms, especially as many of the leaders in her Methodist church were women. She appreciates that Quakerism has always been open to women's leadership, and that it is respectful of speaking of the divine in many ways.

Another suggested that thinking of God as a spirit can help us avoid applying a gender to God. One voiced the thought that humans' often narrow, male perception of God, is what has so often divided us.

There is some surprise that the way Quakers think of God doesn't draw more people to us. **How do we integrate our daily lives with meeting for worship?** 

We agreed we are "at worship" when we are trying to live a life that respects other people and practices kindness, especially to "the least of these" or those who we interact with routinely.

Thomas Kelly's "Testament of Devotion" was recommended as a good source of inspiration for approaching everyday life in a spirit of worship undergirding we do.
