Families of people facing deportation need help getting luggage to loved ones. MMJ is seeking volunteers who can help with luggage drop off in Omaha for Iowans who are being deported by ICE. Tuesdays and Thursdays from 10am-2pm. (It is possible that a volunteer would need to wait for hours for ICE officials to check the bag and OK it for travel.)

The Meeting opened with a Moment of Silence

Approval of Minutes from June 2025 Meeting for Business (Meeting for Business was cancelled for July.)

Minute: The Minutes were approved.

Ministry & Counsel (Jim Dietz-Kilen) July Meeting

We gathered in silence at our appointed time. We spent the meeting discussing ways we might provide care and support for others in our meeting community. The committee completed the State of the Meeting Report for IYM(C) 2025 Annual Sessions.

We have no action items to bring Meeting for Worship with Attention to Business.

We closed with silence.

August Meeting

We gathered in silence at our appointed time.

Petra, Tyler & Family--We discussed our wish to have a pot-luck send-off for Petra, Tyler and family. We have asked them to suggest a date/time or two that would work for them and will then work with Claire to schedule. We also want to organize a time when folks from meeting can help move items from their Des Moines home to storage and are interested in using the Sharing Fund to have professionals move large items for them, if needed.

Care Committee for Pam—Dorothy Lifka, Claire Cumbie-Drake, Susan Myers, Deslonde Lamb & Jan Falb have formed a care committee for Pam.

AVP Training—Cheryl Sutton is willing to offer, under the auspices of Meeting, a three-day training. M&C recommends to Business Meeting that we take Cheryl up on this offer and recruit volunteers to help promote the training and to offer hospitality to participants.

We closed in silence.

Minute: The Meeting approved holding an AVP workshop under the auspices of DMFV. Representatives from Ministry and Counsel and Outreach were asked to meet with Cheryl to discern the details and logistics for a workshop.

Finance Committee (Catherine Dietz-Kilen)
Meeting July 14, 2025
Attendees: Catherine Dietz-Kilen, Katie Jacoby, Dorothy
Lifka and Charlie Brown

1. Financial Reports. The Finance Committee reviewed and approved the financial statements for May and June 2025 for

submission to Meeting for Business.

- 2. The Finance Committee has instituted a practice that, in the event that the statements do not reconcile by an amount \$5.00 or less and the Treasurer has spent two hours to find the problem to reconcile the accounts, the Treasurer need not spend additional time but may instead make a "correction" to the statements via the funds currently held in our budget under bookkeeper. We are no longer paying an outside bookkeeper and therefore believe that next year's budget will not contain a line item for "bookkeeper". We will include a line item for "reconciliation".
- 3. The Finance Committee authorized the Treasurer to make the contributions to the organizations listed under "affiliated contributions" in our budget, at her convenience.
- 4. The Finance Committee will open a credit card at Community Choice Credit Union with the Treasurer and Co-Convenors of the Buildings and Grounds Committee as signors on the card. Repair or maintenance providers will often require payment on the day that work is done on behalf of Des Moines Valley Friends. The coconvenors of the Buildings and Grounds Committee need a credit card in order to make timely payments. The Treasurer will pay any credit card amounts due, in full, prior to the date that balances come due, as it is not our intention to incur interest costs.
- 5. The Finance Committee began our review and editing of the Des Moines Valley Friends

Treasurer's Transition document and completed the first two pages. We will continue with this task at each committee meeting as time allows, with the intention of having a completed document ready for the use of any future treasurer or Finance Committee members. The document will also be available for any member or attender who would like to review it. 6. Action Item. The Finance Business Meeting prepare a copy of the membership records that can be held in the safety deposit box which the Finance Committee will open at Community Choice Credit Union.

7. The Finance Committee's next scheduled meeting will be on the third Wednesday of August at 9:00 a.m. via Zoom, August 20.

Katie reviewed the financial statements with the Business Meeting. There are no outstanding matters related to the Meeting finances. All is in good shape.

Action item: The Finance Committee recommends that the Meeting keep a copy of the membership records in the bank safety deposit box. Forrest is creating a spreadsheet of the membership records. An additional paper copy of the records is also at the Meeting House. The Finance Committee will get a copy of the records to put in the safety deposit box.

Minute: The Meeting approved the Finance Committee report, including the recommendations regarding the membership records.

Building & Grounds Committee (Charlie Brown)

The Business Meeting reconsidered a **Minute** from the June Meeting for Business, as follows:

We are asking Building and Grounds to look into expenses for ceiling fans and curtains for the east windows to cut down on the cost of heating and airconditioning and to review the quote for the replacement HVAC system.

August

Buildings and Ground committee members suggested that the Meeting use fans to help cool the Meeting room, and requested that individuals who are not committee members not "mess" with the thermostat. The committee reminded Friends that it takes up to an hour to cool off the room.

Minute: The Meeting approved the reports, however, no decision was made regarding the matter of adding ceiling fans and curtains on the east windows.

Friends House Board

(Dorothy Lifka)

Meeting, July 18, 2025 Highlights: Renee Cawthorn, FH manager, is taking a "sabbatical" from some of her duties during August and September. She will continue to do "light, administrative work" but will not work on building repairs during those two months.

The board approved formation of an informal building and grounds committee to help get bids on repairs, schedule appointments with contractors and make recommendations to the board. Mike Martin, Katie Jacoby and Charlie Brown have agreed to be on this committee. Immediate concerns are ruling out termites (inactive evidence was found during the elevator inspection), repair of ceiling water damage in several of the offices and replacement of the current air conditioning unit on the third floor.

Dorothy reported that Friends House may be looking for a new property manager.

Peace and Social Concerns Committee (Billie Wade)

Thank you to **Patty Wengert** for handling the backpack donation to Hope Ministries. The committee is very grateful to Patty for taking care of this.

Budget Balance: \$1,960.95 Designated Funds Balance: 1,310.95.

Expenditures, Calendar Year 2025: \$850.00

Billie - A couple of tender requests. Emails about supporting Patty in our donation to Hope Ministries and asking for input on the committee's report to the yearly meeting went unanswered and this was a concern. The members of the committee all committed to

doing better.

David Drake – The Fellowship of Reconciliation (FOR) executive director's note about her arrests while praying in the capitol will be addressed. How might we do something similar here in Des Moines around the cuts in Medicaid and also on the revocation of rights for folks based on gender?

The committee will invite David to fill out our new form for Friends who wish to bring new concerns or leadings to the committee.

Request from Cheryl Sutton:

A change in how we structure soup lunch sign up. She is interested in DMVF using a team approach to potlucks that they use at Bear Creek. Billie will include this as an action item for business meeting to consider.

 Sustaining donations to One Iowa

Peter will reach out to Cecilia Martinez to find out why our May check is still uncashed. We agreed to send another check for \$100 once we have learned why the previous check is uncashed.

- Book reading of American Teenager. Billie will be in touch with Dorothy about this.
- Hosting a 101 from One Iowa. Peter will reach out to Cecilia Martinez to learn more about the specifics on One Iowa implementing their LGBTQ+ 101. How many participants at a minimum? How much is the cost for the workshop? How many hours is the training?
- Creating regular educational spaces for Friends to know how to discuss things like trans rights.
- We agreed to send another check for \$100 for Gaza support to the AFSC.

We will defer the following items until September:

- creating a discernment request form for Peace & Social Issues committee (April)
- Deborah's Concern about Organizing: can we set up a way to communicate if we want to travel or meet with Friends at rallies? (March)
- Petra's creation of a Monthly Calendar to inform, organize and inspire action amongst Friends (February)
- How we are centering the most vulnerable folks being targeted by this Administration (January)

P&SC Meeting - 01 July 2025 Attendees: Billie Wade (Convener), Peter Clay, Jack Holveck, Patty Wingert, Petra Lange

Opened with a moment of silence.

- We considered the logistics of adding PSC events to the DMFV website calendar. Petra drafted a form for Friends to use to invite members of the Meeting to events that they will be attending. The draft can be accessed here:

- We reconsidered David Drake's request sent through email on Monday, Jan. 27, to support a Ute School in Colorado.
- Without further details, we had difficulty discerning an action in support of this school but crafted questions that would help us with future requests. Petra drafted a form for Friends to use to request support from PSC; the draft can be accessed here:

Questions for Form:

- Who is the point of contact from Des Moines Valley Friends Meeting? Who is the point of contact from any other organization referenced in this request?
- What request are you bringing to the Peace and Social Concerns Committee?
- What inspired this request? For example, are these signs part of a local movement in which we are joining in solidarity to support immigrants to our community and Meeting?

- Do you know if other congregations or Meetings have taken the step you are suggesting?
- Are there missteps that we could avoid by learning from how other spiritual communities have implemented specific actions? For example, if the sign does not actually prevent ICE from entering the Meeting House, would people assume it meant we were a sanctuary?
- What is the purpose of taking this particular action? What are your hopeful outcomes of taking this action?
- What is the social issue that you are hoping this action will address? For example, is this sign an effort to support immigrant families? Is it a visual sign of resistance against a specific law? Who will this action benefit?
- What is the relationship that is grounding this request?
- Does someone in our Meeting have a relationship with the organization we would be supporting? How does this benefit vulnerable or marginalized communities and have these communities most affected asked for this assistance?
- Is there a conflict of interest? For example, will the donation made by the PSC committee

- benefit a Friend of the Meeting?
- Our meeting convenes on the first Tuesday of each month, please let us know which of the monthly meetings you would be able to attend in order to answer any questions that might arise.
- We discussed the requests made after the Second Hour with One Iowa and while there was interest in financially supporting One Iowa and learning more through their LGBTQ Inclusivity Training (specifically a session of LGTBQ 101), we were unclear about the financial commitment and will return to the discussion after doing some research.

One Iowa discussion:

- Sustaining donations to One Iowa (How much total?)
- o Hosting a 101 from One Iowa.
- How much does it cost? \$600/hour?
- Creating a literature rack for LGBTQ+ literature.
- Book reading of *American Teenager*.
- Creating regular educational spaces for Friends to know how to discuss things like trans rights.

Hope Ministries:

Patty Wengert will share list of materials needed for the Back to School event.

Minute: The Meeting approved the Peace and Social Concerns Committee reports with gratitude for the hard work of this committee. Meeting approved of the committee developing a form for use by Friends who want to make requests for donations from the Peace and Social Concerns Committee budget. The Meeting also approved of Peace and Social Concerns creating a new format for soup lunch sign-up.

Outreach Committee

(Ann Robinson) No report for July or August. A new attender noted that he learned about the Meeting from the Meeting's table at the Comparison Project event at Drake University. Thank you to the Outreach Committee!

The committee plans to meet in late August.

Library Committee

(Deborah Fisch) No report for July or August.

Nominating Committee (Andrea Holveck)

At the May business meeting, a suggestion by the nominating committee was brought forth by David Drake. We recommend that committee assignments be for a two-year period. Every other year the nominating committee would ask for new committee assignments. Exceptions to the two-year term might include clerk, assistant clerk and recording clerk. We are asking for a discussion about this at our August meeting.

Minute: Friends approve the recommendation that committee assignments be for a two-year period, with the exception of clerk, assistant clerk, and recording clerk. The nominating committee will continue to oversee the process of

discerning who will serve on the various committees.

The Clerk expressed thanks to the members of the nominating committee for their work.

Committee on Migrant & Refugee Concerns (CMARC), (Dorothy Lifka)

CMARC Meeting - July 12, 2025
Peter updated us on funding for DACA renewals through Ames
Sanctuary Interfaith Partners. He suggested that either he or Jean
Hansen could write an article on this for the Friendly Line. We agreed to send \$1210.00 to the fund to pay for two renewals or partial payment for additional renewals.

We received a request for funds for an individual who is friends with a member of DMVF. We decided that we don't have enough information. Dorothy will contact the Friend who requested the help. This might be more appropriately handled by the Sharing Fund.

We discussed a welcoming sign which has been discussed previously in meeting for business and decided that it needs more discussion and seasoning.

Jim has agreed to track the balance in our designated fund.

Dorothy will contact Mak Suceska to reschedule a second hour meeting with him.

We encourage Friends to continue to contact the media and our local, state and federal representatives to speak up in support of migrants and refugees. Next meeting: August 30th at 10:00 a.m. on Zoom.

Minute: The Meeting approved the report, with gratitude to the committee.

IYMC Business, New & Other Business

IYMC:

The IYMC Archives Committee is considering options for how to preserve records of Quaker history in light of the pending closure of the Iowa City Archives library, including the possibility of taking the records back.

Friends revisited the following Minute from the June 2025
Meeting for Business: We will plan to schedule a second hour as soon as possible to discuss this matter and to consider an ad-hoc committee to discuss, which will include Renee from Friends House. We will discuss an invitation to Randy Evans to speak during that second hour.

Friends expressed mixed views on the purpose of commemorating this event, and whether Friends should reach out to other organizations and individuals about participation.

David Drake will reach out to Randy Evans about his availability and willingness to share his experience related to this.

Query #4: Meeting for Worship for Business -Notes from Discussion Sept. 7, 2025

Present: Billie Wade, convenor, Susan Myers, recorder, Dan, Dick Douglas, Andrea Holveck, Deb Fish, Cheryl Sutton, Jack Holveck, Pam Blackburn

How can we hold our meetings for business in the spirit of love, understanding and patient search for unity w/o becoming frustrated by differences of opinion or the pressures of time?

It can be challenging to give ourselves fully, given that some of our meetings for business last up to three hours. We have looked at different ways to address the challenge of using our time well. We recognize, too, that the process of finding the sense of the meeting may take time. Our goal is to get a sense of the Spirit as we gather the sense of the meeting. It may be that when our deliberation takes so long, we have become less centered on where the Spirit is leading us. At these times, we have benefited from the clerk bringing us back to center. At other times, we recognize that we won't complete our process in one meeting.

How do we respond when no one else in the meeting seems to hold the views that we do on an issue?

Sometimes, a person will offer a completely different direction to the conversation, and when this is Spirit-led, it may take the process into a more fruitful of being willing to participate and speak, according to what we are given.

We reflected that we have few people who participate in Meeting for Business and would like to find ways to attract more attenders. Greater involvement is important, as important decisions that affect the entire meeting are often made.

We also considered ways the clerk might keep close-of-business meeting to the stated time. When committees do not have written reports, we can omit an oral report – next time they have an action item, they can bring it forward. We could also ask committees to limit their reports to items business meeting needs to consider. Information that is not action-oriented could be shared in the Friendly Line.

We are grateful for the skill our Clerk brings to our business meetings, including sending the agenda and reports out prior to meeting. We can all benefit by preparing for business meeting by reading this information carefully.

For issues that promise to be controversial, we would benefit from background information on why the issue is important. We also have the opportunity to communicate concerns with other members well before business meeting.

Part of approaching discernment is to remain open to what might be revealed to us through our process, which we may or may not describe using overtly spiritual language. We see the questions in this query as applicable to our daily life. We seek to honor the Spirit within everyone with whom we come into contact, including those who do not consider themselves to be religious.

We appreciate the ethos in DSM Vally Friends, that when a member has a need, we try to step up to fill it. We also appreciate that members and attenders do not hesitate to serve on committees – often multiple ones.

We did not identify any suggested Changes to the Advice and Query.

Query # 5: for October Harmony Within the Meeting

This is my commandment: Love one another as I have loved you John 15:1

ADVICE: It is sometimes difficult to remember that love is a gift of the Divine Spirit and not simply a human emotion. As imperfect human beings, it is not always possible for us to feel loving toward one another, but by opening ourselves to the Light Within, we can receive and give love beyond our human abilities. Relationships among meeting members take time to evolve. Sometimes misunderstandings develop. When differences arise, they should not be ignored for the sake of superficial unity. We believe disagreements which might divide or disrupt a meeting can be resolved through human effort and divine grace, and may result in a stronger and more creative meeting. True harmony depends upon each person's deep respect of and faithful attention to the Divine Spirit within us all. We endeavor to practice humility, attempting to understand positions of others and being aware of the possibility that we may be mistaken.

It is the responsibility of the ministry and counsel committee to be sensitive to needs which may arise. Others in the meeting may be equally concerned, and because of greater understanding in certain cases, be able to give counsel. In reconciliation of differences, a position not previously considered may prove mutually beneficial. At times it may be necessary to confront individuals whose behavior is disruptive. A clearness committee or professional help may be suggested in some situations. We must always remember the power of holding one another in the Light, and the healing that comes from forgiving ourselves as well as others.

QUERIES

- What can we do to deepen our relationships with one another?
- How does gender affect the way we relate to each other?
- How does our meeting balance the needs for honesty and kindness?
- What topics do we avoid for the sake of "unity"?
- When in conflict with others, do we cultivate a forgiving spirit?
- Do we look to that of God in ourselves and seek to address that of God in those with whom we disagree?
